II. Data


- A. There was (1) resident report of abusive sexual contact and sexual harassment that occurred at other institutions during CY2022.
- B. There was (1) resident on resident nonconsensual sexual act report during CY2022.
- C. There was (1) resident on resident sexual harassment report during CY2022.
- D. There was (1) staff on resident sexual harassment report during CY2022.
 - A. 1-6-2022 – Resident reported he was sexually assaulted by other inmates while being housed in the Gallia and Monroe County Jails. The information was forwarded to administrators of both jails.
 - B. 4/7/2022 – Resident alleged he was sexually assaulted by his roommate.
 - C. 11/14/2022 – Residents alleged they were sexually harassed by another resident in their housing unit.
 - D. 12/14/2022 – Residents alleged they were sexually harassed by a staff member working in their housing unit.

*All reports were sent to the appropriate institutions and to ODRC PREA contact.

III. Conclusion

- A. Excluding the other institution report, there were (3) total reports of sexual abuse and/or sexual harassment during the period reviewed. STARCJC maintains a continuous physical presence in the resident living areas and maintains a large video monitoring system. Staff receives annual training on PREA and sexual harassment. This along with our zero-tolerance policy and the accessibility of Management helps to maintain a safe and secure environment.
- B. STARCJC Scioto Campus had a slight increase of PREA related events during CY2022.
- C. STARCJC has access to legal counsel to advise and assist in all PREA investigations.


